8. Eligibility criteria for contesting AOI Governing Body Member

Post - AOI Life membership of at least 5 years.

9. No member can contest for the same post for more than two terms.

10. Any eligible member wishing to update / correct his details in the eligible voter list will have to send a request email from his registered email ID in AOI LM list along with his / her government approved photo ID scanned copy to the AOI Election Returning officer.

11. Only members of good standing are eligible to contest, propose or second a candidate as per the AOI Constitution

12. Last date of campaign for the candidates on social media and public platform is 5th January 2027.

13. Once E - voting starts from 6th January 2027, no candidate can post election related propaganda on What's app groups.

However, candidates can connect with eligible voters via social media platforms on individual basis.
